UBS Boosts Wealth Management via AI

UBS is ramping up AI in its U.S. wealth arm, with 60% of efforts focused on productivity gains—streamlining client onboarding, accelerating KYC, and generating over a million AI-generated prompts monthly. Their in-house AI assistant, Red, is already in the hands of 52,000 employees, with full deployment targeted by mid-2026.

AI-powered asset tokenization is gaining real-world traction

Tokenization is being piloted across key financial markets, notably in bond and equity issuance, where assets are issued digitally on blockchain platforms—cutting underwriting costs and accelerating time-to-market. Additionally, tokenized collateral is enabling real-time margining and risk management across trading venues

Experian's AI-Powered Credit Risk Tool

Launched in early August, Experian's new tool helps financial institutions update, test, and validate credit risk models more efficiently—streamlining compliance, improving model transparency, and optimizing workflows.

Google Finance Gets Smarter

Google Finance in the U.S. is getting an AI makeover: users will soon be able to chat with a finance-focused AI, enjoy enhanced charting tools including candlesticks and indicators, expanded crypto data, and a live news feed—plus an option to revert to the classic layout.



ChatGPT-5 Supports Early Cancer Detection

OpenAI's GPT-5 now includes capabilities to assist in identifying risks for major conditions like cancer, enabling scalable support—especially valuable in remote or underserved areas. OpenAI underscores that this augments rather than replaces medical professionals.

AI dramatically streamlines revenue cycle operations at scale

Omega Healthcare Management Services, a major RCM provider, has integrated AI-powered document understanding tools that extract and process relevant data from medical and insurance documentation. This has saved over 15,000 employee hours per month, reduced documentation time by 40%, cut turnaround times by 50%, and achieved 99.5% accuracy—delivering an impressive 30% ROI for clients.

Ovum AI App Tackles Women's Medical Gaslighting

"Ovum," an AI-powered platform, leverages health history, wearables, and symptom tracking to offer personalized health advice—designed to complement healthcare professionals and address biases in women's health diagnosis. Currently available via app store rollouts and clinical trials.

DeepMind on AI vs Doctors

DeepMind's CEO suggests AI models like AlphaFold and MedPaLM may outperform doctors in analytical diagnostics, but emphasize that nurses provide irreplaceable empathy and interpersonal care that AI cannot replicate



America's Bold AI Action Plan Unveiled

On July 23, the White House released a sweeping AI Action Plan with over 90 policy actions under three pillars: Accelerating Innovation, Building AI Infrastructure, and Leading International Diplomacy & Security. It promotes deregulation, streamlined data-center permitting, workforce development, and open-source support.

"Preventing Woke AI" Executive Order

The administration issued an executive order aimed at ensuring political neutrality in AI systems used by federal agencies—reflecting concerns about ideological bias in models like Google's Gemini

Expanded Federal AI Procurement & Infrastructure Push

Agencies are directed to eliminate procurement and regulatory barriers to AI adoption. Executive Orders also promote export of U.S. AI tech, and expedite permitting for data centers to support scaling

AI Tool to Slash 50% of Regulations

The Department of Government Efficiency (DOGE) introduced an AI-powered tool designed to analyze 200K federal regulations and suggest cutting half by January 2026—potentially saving trillions in compliance costs. Implementation has begun at HUD and the CFPB
